

Does the 26th section give us the rule of descent? The title of the law is, An act prescribing the mode of proceeding in District Courts in matters of probate; and to give the law the effect contended for by appellee, would make it obnoxious to the constitutional provision, that every law enacted by the Legislature shall embrace but one object, and that shall be expressed in the title. Evidently, the statute contemplates only a remedy, and not a rule of right. If I am correct in my view of this statute, it is sustained by the soundest principles of policy and right. If the court below was correct, I venture to say that the statute is not based upon principles of law or morals, and of course not upon grounds of public policy. Should appellee be sustained by the determination of the suit, and marry again and then die, her second husband, being the surviving constituent of the family, would take the home; and should he also marry a second time and die, and his wife survive him, and so on, indefinitely, the homestead would be handed down for all time to strangers, for whom the original proprietor could have felt no concern, in whom...
